## 1. Work Package 6: Long Term Action Plan

### 1.1. Work Package Description

This Work Package is led by CONFAGRI and aims at ensuring the **long-term sustainability of the strategy and training materials**, its future use and the national roadmaps implementation, as well as the curricula uptake by external VET providers. This WP joins the output of the two projects (previous FIELDS Blueprint and the I-RESTART project), to provide for future users one stop source of material that will include, with distinct tags, the outputs in one place. Also collaboration with the Pact for Skills will be expanded in scope and also signed by at least 30 partners coming from the I-RESTART network.

The long-term action plan includes the maintenance of the resources for 4 more years after the project ends. These aims will be reached with:

- provision of national and EU regulatory frameworks for training and innovation opportunities,
- provision of national and EU funding opportunities,
- design of sustainability plan and future use of the platform, with exploitation of project results,
- plan for future engagement of the stakeholders with the signature of I-RESTART MoU that expand the scope of the Blueprint FIELDS project with addition of 30 more partners and with collaboration with the Pact for Skills.

## 2. Task 6.2: Description and Methodology

### 2.1. Task description

In this task partners have studied and listed the funding opportunities available to support the skills strategies and the future use of I-RESTART' outputs.

Two levels have been studied (regional/national and EU levels), each partner listed the regional and national funding opportunities using the EU tender portal and the local authorities materials.

The following partners have been responsible for each country:

- Austria: LVA
- France: ANIA
- Germany: UHOH
- Greece: SEVT & AKMI
- Italy: CONFAGRI and INFOR
- Netherlands: WUR and AERES
- Portugal: Confagri PT
- Spain: FIAB, SCOOP
- Slovenia: GZS-ZKZP
- Denmark: AU
- In addition, a general monitoring will be done at EU level by FDE and ACEEU, EfVET.

The following opportunities at least was monitored for the EU level:

- European structural funds, European Fund for Strategic Investment,
- Erasmus+,
- COSME,

- Youth Employment Initiative,
- Digital Opportunity traineeships,
- European Investment Bank,
- INTERREG,
- FEDER,
- LIFE,
- MSCA.

Two levels were sought, the fundings to put into practice the strategy (implementation of training based on the developed curricula, policy making, etc) and fundings to maintain and ensure the future use of the project outputs (platform maintenance and update, events and opportunities to exploit the training material).

All opportunities will be uploaded in the platform made in T5.4 to ensure easy monitoring and use by partners and external stakeholders.

The consortium will try to prepare applications to one EU and several national schemes by the end of the project to further implement the training.

## 2.2. Task methodology and implementation

The criteria for selecting the funding opportunities were determined by GZS after receiving feedback from partners. The funding opportunities must:

- Be in the European Union
- Be relevant to the projects in terms of:
  - Deals with one or several topics: digitalization, sustainability and bioeconomy, business and entrepreneurship, soft skills, one health, animal production, food industry and veterinary.
  - Partners are eligible to apply for them

The [funding opportunities database](#), which was overseen by UNITO, consists of a table that includes thirteen columns for collecting basic information related to each specific funding opportunity:

1. **Name of the program:** the name of the funding program.
2. **Country:** Country of origin of the call.
3. **Level of funding:** It can be at EU, National, Regional or Local level.
4. **Granting body:** Name of the institution.
5. **Type of funding:** indicates whether a call is decentralized or centralized.
6. **Name of the call:** Full name of the funding opportunity.
7. **Project theme:** indicates which themes of the project are covered by the funding opportunity: digitalization, food industry, animal production, veterinary, soft-skills, one health business/entrepreneurship, sustainability and training. In this column, multiple selection is possible.
8. **Budget:** indicates amount in different budget categories.

9. **Deadline status:** indicates whether the call has closed, is open or has not yet been announced.
10. **Deadline:** indicates deadline date for open calls.
11. **Beneficiaries:** they can be individuals, public organizations, private organizations or both public and private organizations.
12. **Useful links:** official link to the call and to other relevant websites.
13. **Comments:** any observations the partner wishes to add (i.e. specific budget, eligibility, etc.) or ways in which the FIELD5 consortium could take advantage of the funding opportunity.

The task was led by the GZS and was implemented throughout M13 till M30 of the project (September 2023 till February 2025). After meetings with the Work Package lead partner (CONFAGRI), GZS proceeded to develop the structure of the funding opportunities platform so it can be implemented by the web designer (coordinated by UNITO). In parallel, guidelines were prepared to guide the relevant partners in the online platform and entries can be added in an appropriate manner.

### 3. Results of the task

At the closing of the round of consultation with project partners, there were over 120 entries in the [funding opportunities database](#). The results are also presented in the Annex 1 to this document.

## 4. Conclusions and recommendations

There is a wide array of funding opportunities for project partners covering the different project themes and at different levels (EU, National and Regional). Project partners have shown interest to build upon the work done with FIELDS and to do so by forming new partnerships with current members of the consortium as well as expanding the I-RESTART network beyond.

The database can be a very helpful tool for the sustainability of the project but for that to be successful it needs to remain useful to partners. Therefore, it is recommended to update the database 2 or 3 times every year in order to maintain its relevance to project partners.

It is also recommended to provide opportunities for partners to share their new project ideas during I-RESTART work package or task meetings and/or coordinate specific project brainstorming meetings where interested partners can share the opportunities from the database. In this way fostering collaboration within the partnership.

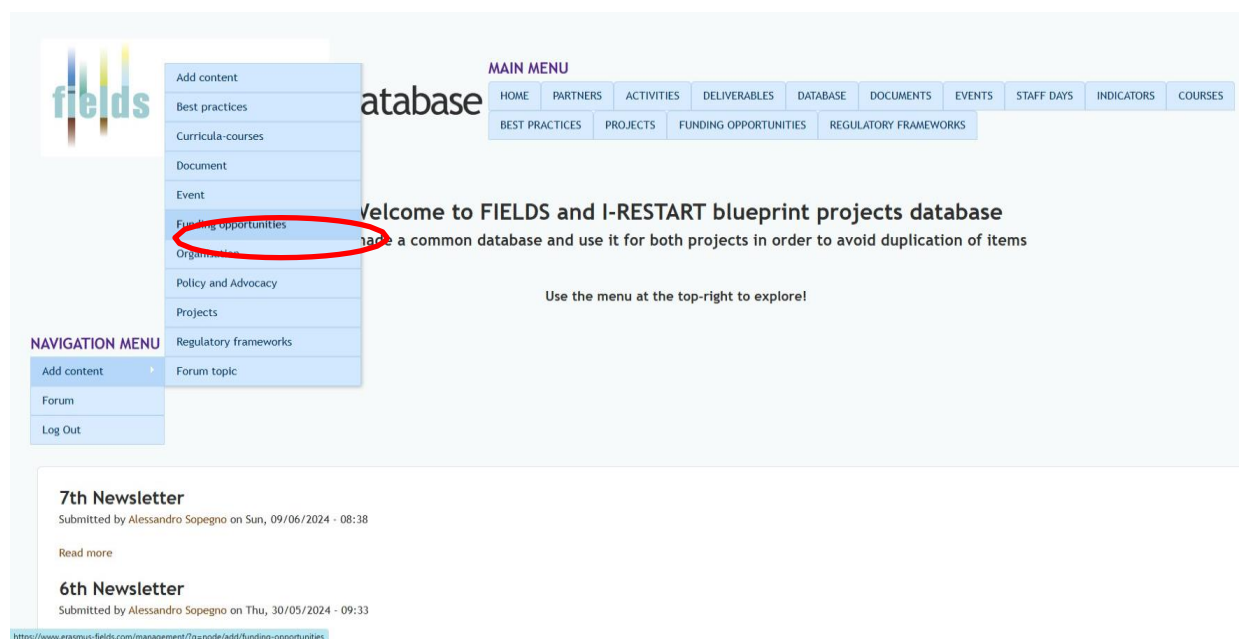
## Annex 2: Guidelines for Funding Opportunities
